



Vineyard Bath Child Protection Policy

1. Introduction

We at Vineyard Bath are committed to a practice which safeguards and promotes the welfare of children.

Staff and volunteers in this organisation accept and recognise our responsibilities to develop awareness of issues which cause children and young people harm. We will safeguard children and young people by –

- Adopting child protection guidelines through a code of behaviour and good practice for all staff and volunteers. **(See volunteer handbook)**
- Sharing information about child protection and good practice with children, parents, staff and volunteers. **(Through our annual CP training for all team members, through our handbook, through weekly best practise)**
- Sharing information about concerns with agencies who need to know, and involving parents and children appropriately.
- Carefully following procedures for safer recruitment in the selection of staff and volunteers **(see our Safer Recruitment Policy)**
- Providing effective management oversight for staff and volunteers through supervision, support and training **(regular team meetings and weekly briefings)**

Vineyard Bath will review our Child Protection Policy, code of behaviour and good practice guidance on an annual basis.

2. Statement of Intent

It is the policy of Vineyard Bath to safeguard the welfare of all children and young people by protecting them from all forms of

abuse or endangerment including physical, emotional and sexual harm. This organisation is committed to creating a safe environment in which young people can feel comfortable and secure while engaged in any of Vineyard Bath's sessions or events.

3. Types of abuse

Neglect: is the persistent failure to meet a child's basic physical and or psychological needs, likely to result in the serious impairment of the child's health or development. Neglect may occur during pregnancy as a result of maternal substance abuse. Once a child is born, neglect may involve a parent or carer failing to:

- Provide adequate food, clothing and shelter (including exclusion from home or abandonment)
- Protect a child from physical and emotional harm or danger
- Ensure adequate supervision (including the use of inadequate care-givers)
- Ensure access to appropriate medical care or treatment.

May also include neglect of, or unresponsiveness to, a child's basic emotional needs.

Physical abuse: may involve hitting, shaking, throwing, poisoning, burning or scalding, drowning, suffocating, or otherwise causing physical harm to a child. Physical harm may also be caused when a parent or carer fabricates the symptoms of, or deliberately induces, illness in a child.

Sexual abuse: involves forcing or enticing a child or young person to take part in sexual activities, including prostitution, whether or not the child is aware of what is happening. The activities may involve physical contact, including penetrative (e.g. rape, buggery or oral sex) or non-penetrative acts. They may include non-contact activities such as involving children in looking at, or in the production of, sexual online images, watching sexual activities, or encouraging children to behave in sexually inappropriate ways.

Emotional abuse: is the persistent emotional maltreatment of a child such as to cause severe and persistent adverse effects on the child's emotional development. It may involve conveying to children that they are worthless or unloved, inadequate, or valued only insofar as they meet the needs of another person. It may feature age or developmentally inappropriate expectations being imposed on children. These may include interactions that are beyond the child's developmental capability, as well as overprotection and limitation of exploration and learning, or preventing the child from participating in normal social interaction. It may involve seeing or hearing the ill-treatment of another. It may involve serious bullying, causing children frequently to feel frightened or in danger, or the exploitation or corruption of children. Some level of emotional abuse is involved in all types of maltreatment of a child, though it may occur alone.

Spiritual Abuse:

In human relationships there are areas of legitimate authority. When power or control is exercised beyond the appropriate boundaries of such authority, whether in the context of a religious organisation or in individual relationships where spiritual authority is claimed, this constitutes spiritual abuse. This can happen when spiritual authority is misused to manipulate peoples' emotional responses (such as fear, guilt or shame) or loyalty, for the benefit of the church, institution or of another individual. Spiritual abuse may also include or underlie other forms of abuse such as sexual, physical, verbal, psychological or emotional abuse when these take place within the context of a religious organisation.

4. Guidelines for all Vineyard Bath staff and volunteers.

Staff and volunteers must at all times show respect and understanding for individual's rights, safety and welfare, and conduct themselves in a way that reflects the ethos and principles of Vineyard Bath. Guidelines are set out in the Kids handbook which is issued to every new team member, and updated biannually.

a. RESPECT

Staff and volunteers are committed to

- Treating children and young people with respect and dignity.
- Always listening to what a child or young person is saying.
- Valuing each child and young person.
- Recognising the unique contribution each individual can make.
- Encouraging and praising each child or young person.

b. BY EXAMPLE

Staff and volunteers will:

- Provide an example which we would wish others to follow.
- Use appropriate language with children and young people and challenge any inappropriate language used by a young person or child or an adult working with young people.
- Respect a young person's right to privacy.

c. ONE TO ONE CONTACT

Staff and volunteers will

- Not spend excessive amounts of time alone with children, away from others. Staff should try to always be visible to others in their contact with children.
- In the unlikely event of having to meet with an individual child or young person make every effort to keep this meeting as open as possible.
- If privacy is needed, ensure that other staff are informed of the meeting and its whereabouts.

d. PHYSICAL CONTACT

Staff and volunteers should never:

- Engage in sexually provocative or rough physical games, including horseplay.
- Do things of a personal nature for a child or a young person that they can do for themselves. If such an incident arises, for example, where a child or young person has limited mobility, Vineyard Bath volunteers should always seek the help of a Vineyard Bath staff member or leader to deal with such an incident.
- Allow, or engage in, inappropriate touching of any kind.

e. GENERAL

Staff and volunteers should:

- Be aware that someone might misinterpret our actions no matter how well intentioned.
- Never draw any conclusions about others without checking the facts.
- Never allow ourselves to be drawn into inappropriate attention seeking situations such as tantrums or crushes.
- Never exaggerate or trivialise child abuse issues or make suggestive remarks or gestures about, or to a child or young person, even in fun.

f. RELATIONSHIPS

Staff and volunteers who are involved in relationships with other members of staff or volunteers should ensure that their personal relationships do not adversely affect their role within or the work of Vineyard Bath.

g. SHARING INFORMATION

Good communication is essential in any organisation. In Vineyard Bath every effort will be made to assure that, should individuals have concerns, they will be listened to and taken seriously.

It is the responsibility of the Leadership of Vineyard Bath to ensure that information is available to, and exchanged between all those involved in this organisation and its activities. Some information is

confidential and should only be shared on a strictly need-to-know basis.

Children & Young People

Children and young people have a right to information, especially any information that could make life better and safer for them. Vineyard Bath will act to ensure they have information about how, and with whom, they can share their concerns, complaints and anxieties.

When sharing information, Vineyard Bath staff and volunteers will be sensitive to the level of understanding and maturity, as well as to the level of responsibility, of the people with whom they are sharing.

Parents

Parents / persons with parental responsibility are ultimately responsible for their children's welfare at all times, and they should be assured that their children are involved with a credible organisation.

We achieve this by

- Publicising information on all Vineyard Bath activities and events for children and young people on our website and through information available on Sunday mornings. This includes regular sessions and activities as well as one off or ad-hoc events that Vineyard Bath may organise or attend.
- Publishing the name and contact details of the Designated Child Protection Person(s) and information as to how to make a complaint.
- Publishing a full copy of this Child Protection Policy and making available any further supporting information it refers to.

Staff & Volunteers

As an organisation, which offers support and guidance to children and young people, it is imperative that each member of the Vineyard Bath staff and volunteer team is aware of their responsibilities under the Child Protection legislation and has a working knowledge of Vineyard Bath's procedures. All Vineyard Bath's staff and volunteer members of the children and young peoples team will be offered

updated training in Child Protection and safe guarding on an annual basis. It will be a requirement that this training is undertaken at least every other year.

Other Bodies

A copy of our Child Protection Policy will be made available to any other appropriate body.

h. PROCEDURES FOR REPORTING ALLEGATIONS OR SUSPICIONS OF ABUSE

All action is taken in line with the following legislation/guidance:

In any case where an allegation is made, or someone in Bath and Avon Vineyard has concerns, a record should be made. Details must include, as far as practical:

- Name of child or young person
- Age
- Home Address (if known)
- Date of Birth (if known)
- Name/s and Address of parent/s or person/s with parental responsibility
- Telephone numbers if available

Is the person making the report expressing their own concerns, or passing on those of somebody else? If so, record details;

- What has prompted the concerns?
- Include dates and times of any specific incidents
- Has the child or young person been spoken to?

If so, what was said?

- Has anybody been alleged to be the abuser?

If so, record details

- Who has this been passed on to, in order that appropriate action is taken? E.g. Vineyard Bath's leadership team, designated child protection person, children's social care
- Has anyone else been consulted?

i. DESIGNATED CHILD PROTECTION PERSONS

- The designated person at Vineyard Bath is Kevin Clark. The deputy designated person is Lizzie Norman.

The designated person will immediately inform Children & Families Assessment Intervention Team (CAFAIT) by telephone. Telephone number: 01225 396312/313 Out of hours telephone number: 01454615165

- The telephone referral to CAFAIT will be confirmed in writing using the form marked C2, within a maximum of 48 hours, ideally 24 hours, with a copy kept by the designated person for child protection.

Essential information will include child's name, address, date of birth, family composition, and reason for referral, name of person receiving the referral and any advice given. This written confirmation must be signed and dated by the referrer.

- Confidentiality must be maintained and information relating to individual children and young people/families shared with staff on a strictly need to know basis.

j. ALLEGED ABUSE BY STAFF, LEADERS, VOLUNTEERS OR TRUSTEES

- When an allegation is made against a member of staff or volunteer, then the allegation must be passed to your designated person for child protection or their deputy or, if the allegation concerns them both, direct to the Local Authority Designated Officer. (LADO)

- Your designated person for child protection should contact one of the Local Authority designated officers for consultation Local Authority Designated Officer (LADO) on **01225 396810** or if unavailable Head of Safeguarding, on **01225 396974** within 1 working day. The designated officer contacted will record a note of the consultation and will advise on the appropriate action that needs to be taken.

k. TRAINING

- The designated person and his/her deputy must receive training every 2 years in Child Protection. Training is available from B&NES Local Safeguarding Children Board.
- All staff and volunteers shall have access to appropriate training on a regular basis, every 2 years. Training will be offered in-house at least every other year with a requirement for all new staff and volunteers to attend.

l. RECORD-KEEPING

- All records, information and confidential notes will be kept in separate files in a locked drawer or filing cabinet at the offices of Vineyard Bath.
- Only the designated Persons or appropriate staff will have access to these files.

m. DISCLOSURE

- Never guarantee absolute confidentiality, as Child Protection will always have precedence over any other issues.
- Listen to the child, rather than question him or her directly.
- Offer him / her reassurance without making promises, and take what the child says seriously.
- Allow the child to speak without interruption
- Accept what is said – it is not your role to investigate or question.
- Do not overreact.
- Alleviate feelings of guilt and isolation, while passing no judgement
- Advise that you will try to offer support, but that you must pass the information on.
- Explain what you have to do and whom you have to tell.
- Record the discussion accurately, as soon as possible after the event.
- Use the child's words or explanations – do not translate into your own words, in case you have misconstrued what the child was trying to say.

- Contact one of Vineyard Bath's Designated Persons for child protection for advice / guidance.

The Designated Person may then discuss the concern / suspicion with the relevant organisation, and, if appropriate, make a direct referral.

If Designated Person is not available, or it is inappropriate to approach them, the volunteer /member of staff with the concern should make direct contact with the relevant organisation themselves.

- Record any discussions or actions taken within 24 hours.
